WHAT IS ISO 50001?

ISO 50001:2018 is the latest version of the best practice international EnMS. It specifies the requirements to enable an organization to develop and implement a policy, identify significant areas of energy consumption and target energy reductions. The new ISO 50001 follows the ISO High Level Structure and risk based approach making it easier than ever to integrate it with existing quality (ISO 9001 QMS), environment (ISO 14001 EMS) and health & safety (ISO 45001 OHSMS) standards based management systems.

WHY CERTIFY TO ISO 50001?

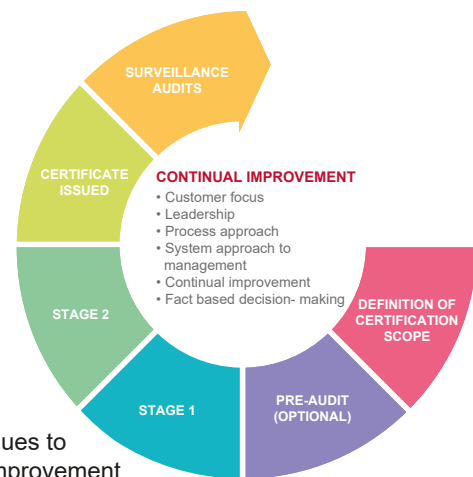
- Check your energy management programme is as good as it can be with continual improvement

HOW DO I CERTIFY?

Key steps in our certification process are:

- **Definition of certification scope**
- **Pre-audit (optional):** gap analysis and diagnosis of your current position against standard
- **Certification audit** performed in 2 stages:
 - **Stage 1** - Readiness review performed to verify that the organization is ready for certification
 - **Stage 2** - Evaluation of implementation, including the effectiveness of the management system of the organization
- A **certificate** valid for 3 years is issued upon satisfactory results of stage 2 audit
- **Surveillance audits** to verify that the management system continues to fulfil the requirements of the standard and monitor the continual improvement
- **Re-certification** after 3 years to confirm the continued conformance and effectiveness of the management system as a whole
